ASC Policies and Procedures
2020-2021 School Year

Availability: ASC will be offered from 12:40-2:40 Monday-Thursday.

Fees: There will be a set rate for the ASC program. The monthly rate will be as follows:

One day a week for one child:	\$35
Two days a week for one child:	\$70
Three days a week for one child:	\$105
Four days a week for one child:	\$140

One day a week for two children:	\$70
Two days a week for two children:	\$140
Three days a week for two children:	\$210
Four days a week for two children:	\$280

One day a week for three children:	\$105
Two days a week for three children:	\$210
Three days a week for three children:	\$315
Four days a week for three children:	\$420

The shorter months of August, December, and May will bill for half the regular monthly tuition. For example, one day a week for one child in August will be \$17.50.

Drop-in Rate: \$10 a day

- **All fees will be auto drafted at the second of each month, including any accumulated drop-in fees.**
- Any changes to a child's ASC schedule MUST be made before the 15th of the month for the following month.
- If your child is enrolled in OMSFA music lessons and plans to use only one hour of the ASC program, **the fee remains the same** because the space has been reserved.
- There is a one-time \$25.00 supply fee per family that will need to be paid with the initial enrollment. The supply fee for faculty members is \$75.00 per family.
- Enrollment forms must be filled out before a child may participate in the program. The deadline for registration for ASC this year is **Tuesday, May 12** in order to streamline the scheduling, billing, and hiring process. Placement is available on a first-come first-serve basis. We recognize that all your plans are not in place yet but have found that a summer deadline is difficult.
- You need to fill out an enrollment form and pay the registration fee even if you only plan to use the drop-in service.
- Parents using the drop-in service will need to call the school office to verify whether a spot is available for the intended day of use.
